ORDER

In the matter of:

CWP No. 1748/2026 titled as Vandana Dhiman, TGT (NM) Vs. State of H.P. & others.

Whereas, Smt. Vandana Dhiman, TGT (NM) presently working in GMS Pukhri u/c GSSS Banikhet, Distt. Chamba has filed CWP No. 1748/2026 titled as Vandana Dhiman, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that she may transferred from GMS Pukhri u/c GSSS Banikhet, Distt. Chamba to one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 16.02.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-


"Accordingly, this petition is disposed of with a direction to the respondents/authority to decide the representation of the petitioner dated 12.11.2025 (Annexure P-1) within a period of three weeks' from today by passing a speaking order and after giving an opportunity of being heard to the petitioner and the same shall be communicated to the petitioner.

It is made clear that this court has not expressed anything on the merits of the case, and the authority shall take a decision strictly in consonance with the provisions of law. Petition stands disposed of, so also the pending application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 05.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Pukhri u/c GSSS Banikhet, Distt. Chamba to GMS Dhangu Peer u/c GSSS Mohtali or GMS Damtal or GSSS Mohtali or GHS Bain Indoria, GSSS kandrori or GSSS lodhwan, Distt. Kangra

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Pukhri u/c GSSS Banikhet, Distt. Chamba since 31.03.2022. Though the said teacher has completed her normal tenure of three years at GMS Pukhri u/c GSSS Banikhet, Distt. Chamba but at present 12 students are studying there. GMS Pukhri u/c GSSS Banikhet falls in soft area. Keeping in view the studies of the students studying at GMS Pukhri u/c GSSS Banikhet, Distt. Chamba. It shall not be feasible to transfer the petitioner because in the absence of TGT (NM) the studies of students, will be affected adversely. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly. If agreed fair draft (speaking orders) is placed below for kind perusal/approval/signature pl.
