## ORDER

In the matter of:

CWP No. 15635/2025- Sh. Sunil Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Sunil Kumar, TGT(NM) presently working in GMS Giankot, u/c GSSS Bharoli, Distt. Sirmour has filed CWPNo.15635/2025 titled as Sh. Sunil Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Giankot u/c GSSS Bharoli, Distt. Sirmour to one of the stations of his choice in Distt. Sirmour. The case of the petitioner was listed before the Hon'ble High Court on 26.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with direction to the respondents/competent authority to decide the pending representation having been filed by the petitioner (Annexure P-9), expeditiously, preferably, within three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy on the ground of adverse family circumstances as well as couple case. Pending applications, if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 30.10.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Giankot u/c GSSS Bharoli, Distt. Sirmour to GMS Nohra u/c Govt. Model Sr. Sec. School Narang. Distt. Sirmour, against vacancy.

After perusal of relevant record, it is revealed that the petitioner has been working in GMS Giankot u/c GSSS Bharoli, Distt. Sirmour since 11.04.2025 and has not completed his normal tenure of three years at his present place of posting. In the transfer policy at clause No. 10 it has been mentioned that the Government can transfer any officer/official at any time irrespective of stay, in view of administrative exigency, in the public interest.

Therefore, keeping in view the clause mentioned in the transfer policy elaborated hereinabove in the above para, the request made by the petitioner on 30.10.2025 is not acceded to. Therefore, the representation of the petitioner is disposed of after due consideration
