Whereas, Anil Kumar, TGT (NM) presently working in GMS Birwari u/c GSSS Diur, District Chamba has filed CWP. No. 16337/2025- titled as Anil Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Birwari u/c GSSS Diur, District Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 16.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation(Annexure P-2) of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon, taking note of the fact that wife of the petitioner is also Government employee and at present, she is working as TGT (Arts) at Government High School Jarot, u/c Government Senior Secondary School Amlela, District Kangra, Himachal Pradesh. Pending application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.11.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Birwari u/c GSSS Diur, District Chamba to GHS Panalath u/c GSSS Harsar or GHS Kaldoon u/c GSSS Tahlian or GHS Harian u/c GSSS Tahlian or GSSS Masroor or GSSS Bhald, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Birwari u/c GSSS Diur, District Chamba since 08.03.2019. Though the said teacher has completed his normal tenure of three years at GMS Birwari u/c GSSS Diur, District Chamba but at present, vacancies are not available in the above mentioned schools where petitioner requested for transfer. The cadre of the TGT (NM) is State Cadre and can be transferred/posted in the state as per transfer policy. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.
