Subject: - Regarding amendment in Recruitment and Promotion Rules of various categories-Clarification thereof.

Madam/Sir,

I am directed to refer to the subject cited above and to say that pursuant to the enactment of the Himachal Pradesh Recruitment and Conditions of Service of Government Employees Act, 2024, the State Government has issued instructions for amendment in Recruitment and Promotion Rules vide instructions of even number dated 05.07.2025. The State Government vide No. PER(AP)-C-B(15)-3/2024-Loose dated 14.05.2025 and No. PER(AP)-C-B(15)-3/2024 dated 19.07.2025 has issued schemes for engagement of incumbents under the State Government as "Trainee" and "Job Trainee", respectively.

2. It has been observed that the Administrative Departments while processing proposals for amendments and framing of Recruitment and Promotion Rules of various categories are replacing the word contract

with "Trainee" and "Job Trainee" which is contrary to the instructions dated 05.07.2025.

3. It is clarified that the proposals for amendments and framing of Recruitment and Promotion Rules of various categories may be processed strictly in accordance with the provisions of instructions issued by the State Government vide Department of Personnel's letter of even number dated 05.07.2025 and the term "Trainee" and "Job Trainee" shall not be inserted in any of the Recruitment & Promotion Rules as these engagements are made under specified schemes.

4. These instructions may be brought to the notice of all concerned for strict compliance.


