Whereas, Raman Kumar, TGT (NM) previously working in GHS Arth u/c GSSS Lahla, Distt. Kangra has filed CWP. No. 10167/2025- titled as Raman Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 03.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

***“Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly enables an employee to seek transfer/adjustment at a convenient station on medical grounds as well as adverse family circumstances. Pending applications, if any, stand disposed of.”***

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 22.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Sansal or GSSS Moondi or GHS Jhikli Bheth, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GHS Arth u/c GSSS lahla Distt. Kangra to GSSS Chopal vide order dated 19.06.2025 in view of CWP No. 9232/2025. GSSS Chopal falls in soft area. At present, vacancies are not available in the above mentioned schools where petitioner requested for transfer. The cadre of the post of TGT (NM) is State Cadre and can be transferred/posted anywhere in the state as per transfer policy. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 “Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.

In the matter of: CWP No. 9977/2025- titled as Vijender Singh, Vs. State of H.P. and others.

Whereas, Vijender Singh, TGT (NM) previously working in GHS Hambot u/c GSSS Hatwar, Distt. Bilaspur has filed CWP. No. 9977/2025- titled as Vijender Singh, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted to one of the stations of his choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 21.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

**"5. Learned counsel for the petitioner attempted to argue that clubbing of previous stay is not permissible in terms of judgment rendered by Co-ordinate Bench of this Court in CWP No. 8605 of 2023, tilted as Anurag Chadha vs. State of Himachal Pradesh but he was unable to dispute that aforesaid judgment has been overruled by the Division Bench of this Court. If it is so, no illegality otherwise can be said to have been committed by the respondents, while clubbing previous stay of the petitioner for calculating total period of stay at present place of posting. However, having taken note of the fact that petitioner's wife is also working in District Kangra, coupled with the fact that transfer policy, enables an employee to seek transfer to a station, where his/her spouse is working, this Court without going into the merits of the case, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority within a period of three days , praying therein for his adjustment at a convenient station on the ground of couple case, which in turn, shall be decided by competent authority expeditiously, preferably within a period of two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy framed by the Government of Himachal Pradesh. Pending applications, if any, also stand disposed of."**

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Badhani or GHS Thathwani u/c GSSS Parol or GHS Nahlwin u/c GSSS Bhotta or GSSS Mahal or GSSS Tal Distt. Hamirpur against vacant post or against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GHS Hambot u/c GSSS Hatwar, Distt. Bilaspur to GMS Karyan u/c GSSS Danoghat, Distt. Solan vide this office letter of even number dated 07.05.2025 with the prior approval of competent authority. As per information received in this office, the petitioner Sh. Vijender Singh, TGT (NM) has joined at the place of his posting in GMS Karyan u/c GSSS Danoghat, Distt. Solan on 09.06.2025 and having short stay. Therefore, keeping in view of position stated above the representation made by the petitioner is not acceded to. The representation is disposed of accordingly.

In the matter of: CWP No. 9957/2025- titled as Madan Lal, Vs. State of H.P. and others.

Whereas, Madan Lal, TGT (NM) presently working in GMS Fatehpur u/c GSSS Kajjiar Distt. Chamba has filed CWP. No. 9957/2025- titled as Madan Lal, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Fatehpur u/c GSSS Kajjiar Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 21.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

**"2. Vide order dated 22.05.2025 passed in CWP No.8517 of 2025, this Court had specifically called upon authority concerned to consider the representation of the petitioner for cancellation of his transfer order on the ground of couple case, however, authority concerned nowhere dealt with the aforesaid point and as such, impugned order dated 08.07.2025 (Annexure P-4) deserves to be quashed and set-aside. Ordered accordingly. Director, School Education, Himachal Pradesh, is directed to decide the representation of the petitioner afresh, strictly in terms of observations made by this Court while passing order dated 22.05.2025 passed in CWP No.8517 of 2025 as well as Transfer Policy, formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer on the ground of couple case. Needful in terms of instant order shall be done expeditiously, preferably, within a period of ten days. Till then, petitioner shall not be compelled to join the transferred station, however, he may avail leave of kind due, if any. Pending applications, if any, also stand disposed of."**

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Fatehpur u/c GSSS Kajjiar Distt. Chamba to GMSSS Matlahar or GMS Harijan u/c GSSS Tahlian or GSSS Chalwara or GSSS Houra Devi. Distt. Kangra against vacant post or longer stayee or against vacancy being caused due to upcoming TGTs promotion to PGTs.

After perusal of the relevant record, it is revealed that the petitioner has been working as TGT (NM) at GMS Fatehpur u/c GSSS Kajjiar Distt. Chamba since 12.09.2018. Though the said teacher has completed his normal tenure of three years at GMS Fatehpur u/c GSSS Kajjiar Distt. Chamba but at present, vacancies are not available in the above mentioned schools where petitioner requested for transfer. The cadre of the TGT (NM) is State Cadre and can be transferred/posted in the state as per transfer policy. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.

In the matter of: CWP No. 10637/2025- titled as Rajender Kumar, Vs. State of H.P. and others.

Whereas, Rajender Kumar, TGT (NM) presently working in GSSS Sahaura, Distt. Kangra has filed CWP. No. 10637/2025- titled as Rajender Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 04.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

**"4. Having taken note of the fact that petitioner has already completed normal tenure of posting at present place of posting and the impugned transfer order has been passed in purported compliance of the order passed by this Court, there appears to be no justification to interfere with the impugned transfer order. However, having taken note of the fact that son of the petitioner is 75% disabled by birth and petitioner, prior to his impugned transfer, had made representation to the Deputy Director Elementary Education Kangra (Annexure P-3), thereby requesting to provide relaxation in routine transfer, this Court, without going into the merits of the case deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority within a period of one week, seeking transfer/adjustment at a convenient station on the ground of adverse family circumstances, which in turn, shall be decided by the competent authority within a period of two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of Office Memorandum (Annexure P-2), sub para 5.6 whereof talks about certain concessions to the officials having differently abled dependents. Till the time representation, if any, filed by the petitioner within a period of one week, is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."**

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Sahaura or GSSS Passu or GSSS Bagli or GSSS Zamanabad or GHS Nandher or DIET Dharamshala, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GSSS Sahaura, Distt. Kangra to GMS Lohani, u/c GMSSS Salooni, Distt. Chamba vide order dated 01.07.2025 with the prior approval of the competent authority. GMS Lohani, u/c GMSSS Salooni falls in soft area.
