In the matter of: CWP No. 14367/2025- titled as Tilak Raj, Vs. State of H.P.
and others.

Whereas, Tilak Raj, TGT (NM) presently working in GHS Graman u/c GSSS Thaltukhod, Distt. Mandi (Sub cadre) has filed CWP. No. 14367/2025- titled as Tilak Raj, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Graman u/c GSSS Thaltukhod, Distt. Mandi to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 05.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation (Annexure P-2) of the petitioner, expeditiously, preferably, within a period of three weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of the fact that one post of TGT (NM) is lying vacant at GHS Sagoor, under complex GSSS Rakkar, District Kangra and GSSS Ahuja, District Mandi. Pending application(s), if any, shall also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 25.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Sagoor u/c GSSS Rakkar or GHS Jhikli Bheth or GSSS Gadiara or GSSS Paprola or GMSSS Sansal or GHS Harer Distt. Kangra against vacant post or Longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working at GHS Graman u/c GSSS Thaltukhod, Distt. Mandi (Sub Cader) Since 23.09.2022 and has completed his normal tenure of three years at present place of posting. At present, one post of TGT (NM) is lying vacant at GHS Jhikli Bheth, Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GHS Graman u/c GSSS Thaltukhod, Distt. Mandi to GHS Jhikli Bheth, Distt. Kangra against vacancy without TTA/JT as per his request.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
