**ORDER**

In the matter of: CWP No. 7856/2025-Sudesh Dogra, TGT (Arts) V/s. State of Himachal Pradesh.

The petitioner has filed CWP No. 7856/2025 titled as Sudesh Dogra V/s State of Himachal Pradesh seeking the relief to the extent that the petitioner may be adjusted either at GSSS Bhukkar (HMR), GSSS Longni/Hawani/Nabahi Distt. Mandi, against vacancy/longer stayee. Smt. Sudesh Kumari, has represented that her Mother in Law is suffering from Psychiatric (Mental Disorder) and no other member in the family who can look after her Mother in Law.

From the perusal of record, it is found that Smt. Sudesh Dogra, TGT (Arts) was transferred from GSSS Bhaderwar (MND) to GHS Chet u/c GSSS Cheuni (MND) vice Sh. Vijay Kumar, TGT(Arts) and vice versa basis on dated 07.5.2025. The petitioner has completed her normal tenure at GSSS Bhaderwar Distt. Mandi. At present no any post of TGT (Arts) is lying vacant in ibid mentioned schools.

In view of above narrated facts and as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected. The representation of the petitioner with the present CWP is disposed of accordingly.
