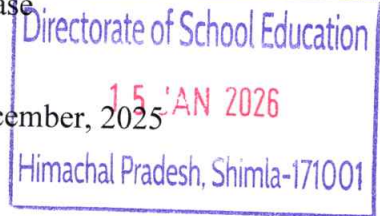

ORDER

In the matter of:- CWP No. 14717/2025-titled as Kriti Pathania, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 14717 of 2025 titled as Kriti Pathania Vs State of HP in the Hon'ble High Court vide which sought her transfer from GSSS Sarounjh Distt. Mandi HP (i.e. difficult area) to soft area. The present CWP was listed before the Hon'ble High Court of H.P. on 11.09.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 22-12-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Smt. Kriti Pathania, TGT (Arts), submitted fresh representation and stated that she is working at GSSS Sarounjh Distt. Mandi and requested for transfer/adjustment at GSSS Katindhi (Mandi) against vacancy being caused due to retirement of present incumbent on 31.01.2026 on account of completion of normal tenure.

From the perusal of the record, it is found that Smt. Kriti Pathania, TGT (Arts), is working at GSSS Sarounjh Distt. Mandi since 23.10.2018, she has completed her normal tenure at present place of posting and one post of TGT (Arts) is going to vacant at GSSS Katindhi (Mandi). In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Smt. Kriti Pathania, TGT (Arts) posted at GSSS Sarounjh Distt. Mandi is hereby transferred/adjusted at GSSS Katindhi (Mandi) against vacancy being caused due to retirement of present incumbent on 31.01.2026. without TTA/JT. The petitioner will join after superannuation of present incumbent. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.

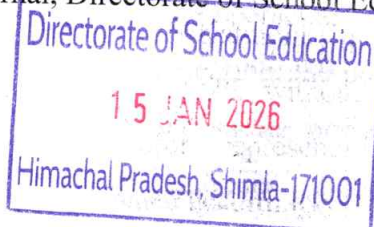
