ORDER

In the matter of:-

CWP No. 8621/2025-titled as Nageshwar Singh, TGT (Arts) V/s. State of HP.

The petitioner transfer order dated 21.05.2025 was issued from GSSS Mera Masit Distt. Mandi to GHS Gahan Distt. Shimla. Feeling aggrieved, petitioner Sh. Nageshwar Singh, TGT (Arts) has filed present CWP in the Hon'ble High Court and sought his adjustment. The case was listed before the Hon'ble High Court of H.P. on 24.07.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

“.....Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek cancellation of transfer/adjustment at a convenient station on account of couple case..”

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 14.08.2025 and appeared before the undersigned on the scheduled date. The petitioner (Sh. Nageshwar Singh, TGT (Arts) has requested that his wife is also a Govt. employee and is working in the Revenue Department at Dharampur Distt. Mandi therefore sought his adjustment either at GSSS Galma,GHS Balt, GSSS Mundroo, GSSS Trou.

From the perusal of record, it is found that Sh. Nageshwar Singh, TGT (Arts) was transferred from GSSS Mera Masit Distt. Mandi to GSSS Gahan Distt Shimla and the institution is classified as a soft area within District Shimla. Further Sh. Nageshwar Singh, TGT (Arts) has already joined his duty at GHS Gahan Distt Shimla joined on June, 2025. Furthermore, Sh. Nageshwar Singh, TGT (Arts) has not previously served in a hard or tribal area. Additionally, in CWP No. 10255/2025, titled Bharti Rathour Vs. State of HP, the Hon'ble High Court emphasized that all departments must ensure that each employee is assigned to a sub-cadre or tribal area at least once during their service career.

Keeping in view, the above facts and circumstances, the case of the petitioner for adjustment cannot be considered at this stage as the petitioner has already been joined at transferee school i.e. GHS Gahan Distt Shimla. Hence, the representation of the petitioner is disposed of accordingly.

CWP No. 9358/2025-titled as Sandeep Kumar Chauhan, TGT (Arts) V/s. State of HP & Ors.

The petitioner transfer order dated 31.05.2025 was issued from GSSS Jarol Distt Mandi to GMS Ghatta u/c GSSS Chauntra Distt. Mandi. Feeling aggrieved, petitioner Sh. Sandeep Kumar Chauhan, TGT (Arts) has filed present CWP in the Hon'ble High Court and sought his adjustment. The present CWP No. 9358/2025 was listed before the Hon'ble High Court of H.P. on 22.07.2025, on this day Hon'ble Court has passed order/judgment that "the petitioner intends to represent to the respondents."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 12.08.2025 & 03.9.2025 and petitioner was appear before the undersigned on 03.09.2025 on this day he has stated that his father was expired in a truck accident and mother is suffering from various diseases and no other member in the family who can look after her mother so that petitioner has sought his transfer either to GHS Dharanda/GSSS Tawan/GSSS Jaidevi Distt Mandi.

From the perusal of record, it is found that Sh. Sandeep Kumar Chauhan, TGT (Arts) was posted at GSSS Jarol Distt Mandi and his transfer order was issued to GMS Ghatta u/c GSSS Chauntra Distt. Mandi vice Smt. Seema Kumari, TGT (Arts) by clubbing petitioner stay within the radius of 30 Kms. At present post of TGT (Arts) is lying vacant at GSSS Tawan Distt. Mandi wherein about 54 students are enrolled.

Sandeep Kumar Chauhan, TGT (Arts) is hereby transferred/adjusted at GSSS Tawan Distt. Mandi against vacancy (without TTA/JT). CWP No. 14003/2025-titled as Anita Kumari, TGT (Arts) V/s. State of HP and others.


The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from GSSS Bharoli, Distt. Sirmour (HP) to one of the station of her choice. The present CWP was listed before the Hon'ble High Court of H.P. on 30-08-2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Consequently, in view of fair stand adopted by learned Additional Advocate General, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with the direction to respondents to consider and decide the pending representation of the petitioner (Annexure P-2), expeditiously, preferably, within a period of two weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms 3 of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of Transfer Policy, formulated by the Government of Himachal Pradesh, relevant provisions whereof have been already taken note hereinabove.."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 10.09.2025 and appear before the undersigned on scheduled date. The petitioner has stated that she has completed normal tenure at present place of posting i.e. GSSS Bharoli, Distt. Sirmour therefore, sought/requested her transfer either to GHS Dabla/ GSSS Kalol / GSSS Talyana / GSSS Suin / GSSS Kothi, Distt. Bilaspur (HP).

From the perusal of record, it is found that Smt. Anita Kumari, TGT (Arts) is working at GSSS Bharoli, Distt. Sirmour since 19.12.2020 and has completed her normal tenure at present place of posting. At present post of TGT (Arts) is lying vacant at GSSS Kalol, Distt. Bilaspur (HP) wherein 128 students are enrolled.

In view of above narrated circumstances, the representation of petitioner has been considered sympathetically and the petitioner i.e. Smt. Anita Kumari, TGT (Arts) is hereby transferred/adjusted from GSSS Bharoli, Distt. Sirmour to GSSS Kalol, Distt. Bilaspur against vacancy (without TTA/JT). The representation of the petitioner in the present CWP stands disposed of. All the concerned be intimated accordingly.
