ORDER

Whereas, Neeraj Kumar, Lecturer (School-New) English presently posted at GSSS Dharampur, Distt. Una was filed CWP No. 8170/2025 before the Hon'ble Court, seeking direction to respondent to consider and decide his pending representation wherein he has requested to adjust him another station i.e. GSSS Naila (BLL) as where he has been transferred i.e. GSSS Dharampur (Una) is likely to be downgraded in near future.

The case was finally disposed of by the Hon'ble High Court on 19.05.2025 with the following directions:-

"Having regard to the aforesaid submissions and without interfering with the respondent No.5's transfer under the impugned order, this writ petition is disposed of by directing the respondent No.2/Competent Authority to consider and decide the representation of the petitioner dated 15.05.2025 (Annexure P-3) in accordance with law and as per applicable transfer policy, within one week from today. Copy of decision so taken, be communicated to the petitioner".

And whereas, upon passing of above directions, while examined his representation it is found that he has already joined at transferred station i.e. GSSS Dharampur (Una) on 22.05.2025 as well as GSSS Naila (BLP) is not lying vacant. Moreover, as per "Comprehensive Guiding Principles-2013" for regulation the transfer of State Government employees it is clearly mentioned at Rule-12.1 that no government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.
