The petitioner has filed the present CWP No. 15610 of 2025 in the Hon'ble High Court concerning his transfer representation dated 14.09.2025, through which he has sought his transfer from GSSS Banoli, District Kangra, to a station of his choice. The present CWP No. 15610 of 2025 was listed before the Hon'ble High Court of H.P. on 26.09.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 21-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Anil Kumar, TGT (Arts), submitted fresh representation and stated that he is working at GSSS Banoli Distt. Kangra and completed his normal tenure at present place of posting so that requested for transfer/adjustment at GSSS Dinilarth, GMS Bhaloon u/c GSSS Matlahar or GSSS Harsar Distt Kangra.

From the perusal of the record, it is found that Sh. Anil Kumar, TGT (Arts), is posted at GSSS Banoli Distt. Kangra since 23.07.2020 and completed his normal tenure at present place of posting. Further the institution GSSS Banoli, is situated in a soft area of district Kangra, wherein about 70 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right."

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GSSS Banoli Distt. Kangra. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
