## ORDER

Sh. Sohan Lal, TGT (Med.) has filed CWP No. 12382/2025 titled as Sohan Lal V/s. State of H.P. in the Hon'ble High Court, and seeking his transfer from GHS, Hellan u/c GSSS, Baga Chanogi Distt. Mandi (Sub cadre/hard area) either to GSSS, Dashera Distt. (Mandi) GSSS, Tandoo, GSSS Badog GHS, Mehni U/c GSSS, Gharan Distt. (Mandi). The case was listed before the Hon'ble High Court of H.P. on 30.07.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under-

"Looking to the nature of the grievance raised in this writ petition, it would in the interest of justice to direct competent Authority to consider and decide the aforesaid representation (Annexure P-4) of the petitioner in accordance with law and as per applicable policy within aperiod of three weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner.

As per the direction of the Hon'ble High Court the petitioner was called for personal hearing and attended the personnel hearing on 25.08.2025. Sh. Sohan lai, TGT (Med.) has requested to adjust him at GSSS, Dashera Distt. (Mandi) GSSS, Tandoo, GSSS Badog GHS, Mehni U/c GSSS, Gharan Distt. (Mandi) after completion of normal tenure in hard/sub cadre area.

From the perusal of record, it is found that Sh. Sohan Lal, TGT (Med.) is working at GHS, Hellan u/c GSSS, Baga Chanogi Distt (Mandi) (Sub cadre/hard area) since 27.04.2022 and has completed normal tenure at his present place of posting. At present one post of TGT (Med.) is lying vacant at GHS, Mehni u/c GSSS, Gharan Distt. (Mandi).

Keeping in view the position stated above, representation of the petitioner i.e Sh. Sohan Lal, TGT (Med.) is considered sympathetically and hereby transferred from GHS, Hellan u/c GSSS, Baga Chanogi Distt. Mandi to GHS, Mehni u/c GSSS, Gharan Distt. (Mandi) against vacancy, without TTA/JT on his own request. The representation of the petitioner is disposed of accordingly.
