In the matter of: CWP No. 8605/2025-titled as Deepak Kumar, Vs. State of H.P. & Others.

Whereas, Deepak Kumar, TGT (NM) preferred CWP No. 8605/2025 titled as Deepak Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Adu, U/C GSSS Bagalati, Distt. Shimla, H.P. to nearby his native place in Distt. Bilaspur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 23-05-2025 when the Hon'ble High Court has passed the following orders:-

" In view of the above, petitioner is permitted to make representation to the competent authority for his adjustment at a convenient station in terms of transfer policy, which in any eventuality, shall be decided by the competent authority on or before the next date of hearing. Respondents, while doing so in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy formulated by Government of Himachal Pradesh, which enables an employee to seek transfer/ adjustment on the ground that he/she is nearing to retirement. List on 30.05.2025."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office on 30-05-2025, vide which He has requested that He may be transfer from GMS Adu, U/C GSSS Bagalati, Distt. Shimla, H.P to nearby his native place in district Bilaspur, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. .

From perusal of record, it has been found that the petitioner has been working at GMS Adu, U/C GSSS Bagalati, Distt. Shimla, H.P since 15-09-2020 and has completed his normal tenure at present place of posting. One Smt. Ambika Sharma, TGT(NM) is working in GHS Salnoo, Distt. Bilaspur, H.P. since 10-06-2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and He is hereby transfer from GMS Adu, U/C GSSS Bagalati, Distt. Shimla, H.P. to GHS Salnoo, Distt. Bilaspur, H.P. vice Smt. Ambika Sharma, (NM) against longer stay, with TTA/JT to Smt. Ambika Sharma, TGT(NM). The representation of the petitioner is disposed of accordingly.
