Whereas, Sh. Sudershan Singh, TGT (NM) who is U/t from GMS Kathiara u/c GSSS Garli, Distt. Kangra to GHS Panjala u/c GSSS Sansal, Distt. Kangra has filed CWP No. 7865/2025 titled as Sudershan Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer/adjustment in Distt. Kangra, against vacancy/longer stay by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14.05.2025 when the Hon'ble High Court has passed the following orders:-

"For the reasons stated hereinabove, though this Court sees no reason to interfere in the impugned transfer order, but having taken note of the fact that wife of the petitioner is serving in District Kangra, coupled with the fact that petitioner is unwell, as is evident from the medical documents adduced on record, this Court deems it fit to dispose of the present petition, with a direction to the petitioner to file representation to the competent authority within a period of one week, praying therein for his adjustment at nearby station, which in turn, shall be decided by the competent authority within a period of 4 one week, taking note of observations made hereinabove as well as provisions contained in the transfer policy, which enables an employee to seek transfer/ adjustment on the ground of couple case as well as adverse medical condition. Till the time, representation, if filed by the petitioner within a period of one week, is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station in terms impugned transfer order. Pending applications, if any, also

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner stand disposed of." was called for personal hearing on 19.06.2025. He has attended the same and submitted his representation in this office on 19.06.2025 vide which he has requested that he has completed normal tenure at his present place of posting i.e. GMS Kathiara u/c GSSS Garli, Distt. Kangra and he further requested that he may be transferred/adjusted in Distt. Kangra, against vacancy/longer stay by clubbing his/her previous stay. At present post of TGT (NM) are not lying vacant in the above mentioned school.

From perusal of record, it has been found that the petitioner has been working at GMS Kathiara u/c GSSS Garli, Distt. Kangra and under of transfer to GHS Panjala u/c GSSS Sansal, Distt. Kangra. One Smt. Seema Kumari, TGT (NM) is working in GHS Upper Bhalwal u/c GSSS Bathra, Distt. Kangra, since 09.07.2020 and has completed three years stay there. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within the radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transfer from GMS Kathiara u/c GSSS Garli, Distt. Kangra to GHS Upper Bhalwal u/c GSSS Bathra, Distt. Kangra vice Smt. Seema Devi, TGT (NM) against longer stay by clubbing his/her previous stay, without TTA/JT and Smt. Seema Devi, TGT (NM) is hereby transferred to GSSS Mangli, Distt. Chamba, against vacancy, with TTA/JT. The representation of the petitioner is disposed of accordingly.
