**"ORDER"**


Whereas the petitioner Sh. Suneel Kumar, Lect./Lect.(SN) Physics is working at GSSS Gahlian, Distt. Bilaspur w.e.f. 16.09.2022 & as such his stay is complete. Feeling aggrieved he filed CWP No 9601/2025 titled as Suneel Kumar Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 11.11.2025 when the same was finally disposed with the directions to respondents as under:-

"Since petitioner has already completed normal tenure of posting at present place of posting, this Court sees no reason to interfere with the impugned transfer order, however, having taken note of ground of couple case raised by the petitioner, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation within a period of one week to the competent authority, praying therein for his transfer/adjustment at a convenient station, which in turn shall be decided by the afore authority expeditiously, preferably, within a period of ten days, in terms of Transfer Policy, formulated by the Government of Himachal Pradesh. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of the fact that wife of the petitioner is also a Government employee and at present, she is teaching at GSSS Salwad, District Bilaspur. Till the time, representation, if filed within the time stipulated by this Court, is not decided by the competent authority, interim order passed by this Court shall remain in force. Pending applications, if any, also stand disposed of.

And whereas upon passing of above directions, the representation of petitioner has been perused and examined and it has been observed that he has requested for his adjustment/ transfer either at GSSS Salwad,(BLP)/ Berthin, (BLP)/ GSSS Ghumarwin, (BLP) against vacancy.

And whereas as per direction passed by the Hon' ble High Court as above, the applicant was called to appear in this office for personal hearing on 22.12.2025 and was present on this date. During the course of hearing the applicant has pleaded that his father is aged about 66 years and suffering from cancer IV stage and there is no male member in the family of the applicant to look after his ailing father, it would be very difficult for the applicant to look after his ailing father.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected on the ground that petitioner is posted at soft area station and the incumbents posted at the station of choice of the petitioner are having short stay. Accordingly his representation stand disposed of.


