**ORDER**

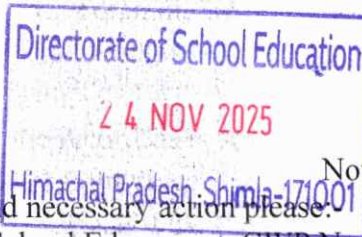
In the matter of:- CWP No. 17341/2025-titled as Ajay Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 17341 of 2025 in the Hon'ble High Court vide which sought his transfer at one of the station, as detailed in the representation. The present CWP was listed before the Hon'ble High Court of H.P. on 07.11.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 21-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Ajay Kumar, TGT (Arts), submitted fresh representation and stated that he is working at GHS Dhar u/c GSSS Jadera Distt Chamba (hard area) since 25.02.2022 and completed his normal tenure at present place of posting so that requested for transfer/adjustment at GHS Totarani, GMS Balh, GSSS Boh, GSSS Kareri, GHS Kareri Khas Distt. Kangra.

From the perusal of the record, it is found that Sh. Ajay Kumar, TGT (Arts), is posted at GHS Dhar u/c GSSS Jadera Distt Chamba since 25.02.2022 and completed his normal tenure at present place of posting. At present (01) one post of TGT (Arts) is lying vacant at GHS Kareri Khas u/c GSSS Kareri Distt. Kangra, wherein about 97 students are enrolled, which also falls within the choice station of the petitioner.

Keeping in view the position stated above, representation of the petitioner is considered sympathetically as per transfer policy and Sh. Ajay Kumar, TGT (Arts) is hereby transferred from GHS Dhar u/c GSSS Jadera Distt Chamba to GHS Kareri Khas u/c GSSS Kareri Distt. Kangra against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
