ORDER

In the matter of:

CWP No. 15360/2025- Sh. Prince Kumar, TGT(NM) Vs. State of H.P. and

Whereas, Sh. Prince Kumar, TGT(NM) presently working in GSSS Kalhel, Distt. Chamba has filed CWP No.15360/2025 titled as Prince Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Kalhel. Distt.Chamba to one of the stations of his choice in Distt. Chamba. The case of the petitioner was listed before the Hon'ble High Court on 23.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"The prayer made in the petition is innocuous and the same is allowed. Respondent No.2 is directed to consider and decide the representation of the petitioner, Annexure P-2, within three weeks from today strictly in terms of the transfer policy adopted by the State Government. The petitioner shall be given an opportunity of being heard by the second respondent before taking final decision on the representation. Accordingly, the petition stands disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 01.11.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Kalhel, Distt. Chamba to GHS Shakti Dehra u/c GSSS Kiani or GSSS Sarol or GSSS Pukhri or GSSS Rajnagar or GSSS Kiani or GMS Hamal Gala u/c GSSS Masroond or GSSS Masroond or GMS Draman u/c GSSS Sach, Distt. Chamba.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Kalhel, Distt. Chamba since 21.02.2022 on regular basis and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GMS Draman u/c GSSS Sach, Distt, Chamba.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GSSS Kalhel, Distt. Chamba to GMS Draman u/c GSSS Sach, Distt. Chamba, against vacancy without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
