

ORDER

Whereas, Sheela, Lecturer (School-New) (English) was filed CWP No. 8512/2025 before the Hon'ble High Court against her transfer from GSSS Sianj (Mandi) to GSSS Keolidhar (Mandi) issued vide this office order dated 17.5.2025 on the grounds that her transfer was made on the basis of D.O. note and to accommodate respondent No.4 and medical problems of her husband.

The case was listed before the Hon'ble Court on 22.5.2025 when the case was disposed of with the following directions:-

"In view of above submission, and without interfering with the transfers of respondents No.3 and 4 under the impugned order, but keeping in view petitioner's contentions that her transfer to a particular place has been ordered on the basis of a D.O. note and keeping in view of her family circumstances, this writ petition is disposed of by permitting the petitioner to make representation to the Competent aAuthority for her suitable transfer/adjustement within a two days, thereafter, the same shall be considered and decided by the Competent Authority in accordance with law and applicable transfer policy within next ten days. Copy of decision so taken, be communicated to the petitioner".

And whereas, upon passing of above directions, petitioner i.e. Smt. Sheela, Lecturer (School-New) (English) has submitted her representation vide which she has requested to adjusted her at GSSS Moviseri (Mandi) against vacancy being medical problems of her husband as well as family circumstances.

And whereas, that the matter has been examined and found that petitioner was transferred to GSSS Keolidhar (Mandi) after completion of her stay at present place of posting and it is also found that petitioner was serving within the radius of 30 KM since 2018 and continuous services rendered by employees of Edcuation Department within a radius of 30 Kms will be considered stay/tenure at one station, & such services will be clubbed for calculation of tenure for purpose of transfer as per Government Instructions dated 27.10.2013 and as per "Comprehensive Guiding Principles-2013" for regulation the transfer of State Government employees it is clearly mentioned at Rule-12.1 that no government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenienceon.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected and further directed to join at GSSS Keolidhar (Mandi).

With these observations, representation stand disposed of.
