## ORDER

Whereas, Sh. Ishwar Chand, JBT has filed CWP No. 15763/2025 before the Hon'ble High Court for transfer from Distt Chamba to Distt Sirmour HP. under 5% inter-district quota. The case was listed before the Hon'ble High Court on 06.10.2025, when after the hearing Hon'ble High Court has passed order as under:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation of the petitioner, expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order thereupon taking note of notification dated 20.11.2021, which certainly enables an employee to seek transfer from one district to another district under 5% inter-district quota, after his/her having completed five years in one district. In the aforesaid terms, present petition is disposed of along with pending application(s), if any."

In compliance of the orders the Hon'ble High Court of H.P, petitioner was called to appear in person on 21.11.2025. On the date of hearing, the petitioner appeared before the undersigned and has requested that he is eligible for this transfer under 5% inter-district transfer policy, submitted the representation on 21.11.2025. The petitioner Sh. Ishwar Dass, JBT has further requested for his transfer under 5% inter district quota from District Chamba to Distr Sirmour, HP.

Whereas, comments were obtained from the Deputy Director of School (Elementary) Education, Chamba. after the perusal of comments/proposal, it is revealed that in Distt Chamba has the total strength of JBTs is 2258 out of which 112 posts lying vacant. At present, (03) three posts of JBTs are sanctioned, all of are filled(including the petitioner) on the enrollment 60 in GPS Dhar.

And whereas, it is Pertinent to mention that, if the teacher(petitioner) is transferred to another district, which will adversely affect the academic interests of the students, especially in the midsession, due to shortage of teaching staff.

And whereas, the Government of HP vide office No. EDN-A-Kha(1)1/2022, dated 04 June 2025, has imposed complete ban on transfers of teaching staff. Moreover, transfer to a particular place of choice cannot be claimed as a matter of right. It is on the discretion of the State Govt. to post/transfer any employee anywhere in the District/State, keeping in view of the exigencies/conveniences.

Keeping in view of administrative exigencies and above facts, the representation of the petitioner is examined, after due consideration, the request of the petitioner is not tenable and is hereby rejected and disposed of, accordingly.
