## ORDER

Whereas, the petitioner namely Prem Raj, Lect(History) was transferred from GSSS Karyuni(Chamba) to GSSS Guwan (Chamba) vice Babita Kumari Lect(History) and vice versa by clubbing his previous stay on dated 19.05.2025. Feeling aggrieved against these orders he filed CWP No. 8611/2025 titled as Prem Raj vs State of HP before the Hon'ble High Court seeking there in relief, which was listed on dated 04.06.2025 when the Hon'ble Court has given following directions as under:-

"Though this court is not inclined to interfere in the impugned transfer order, however having taken note of the fact that petitioner herein has already served hard/tribal area for considerable time, this Court deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation within three days to the competent authority, praying therein for concellation/adjustment at a convenient station. Ordered accordingly.

The representation so filed shall be decided by the competent authority within ten days. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy formulated by the Govt. Of Himachal Pradesh, which certainly enables an employee to seek transfer/adjustment in soft area or station of his/her choice after his having served hard area. Till the time representation is decided by the cometent authority, petitioner shall not be complled to join at the transferred station, whereas respondent No. 3. who pursuant to impugned transfer order has already joined at GSSS Karyuni, shall continue to render his service in the afore school pursuant to his joining on 20.03.2025."

And whereas, upon passing of order dated 04.06.2025, the representation from the petitioner has been received and he was called for personal hearing on 30.06.2025 but not appreared and called again on 07.07.2025. During the course of hearing and in his representation he has requested that he was transferred from GSSS Karyuni(Chamba) to GSSS Dharwas(Chamba) within one month as earlier he was serving at GSSS Dharwas(Chamba) and was transferred to Karyuni(Chamba) on 25.04.2025. Hence, he may be adjusted either at GSSS Sach(P) or GSSS Sechunala(P) (Chamba) against vacancy.

And whereas, as per direction passed by the Hon'ble Court as above, request of the petitioner has been considered and found that the respondent No. 3 i.e Smt. Babita Kumari has rejoined at GSSS Karyuni(Chamba) on 09.06.2025 with the direction of Hon'ble Court and the petitioner is also at GSSS Karyuni(Chamba. The post of Lecturer History is lying vacant GSSS Sechunala(Chamba) and some other Lect(History) is already under transfer to GSSS Sach(P)(Chamba) and having Court case.. Hence, the request of the petitioner is being allowed/considered to GSSS Sechunala(Chamba) against vacancy to vacate the surplus arrangement.

Now therefore, after taking into account the above discussed detailed facts and circumstances the petitioner i.e. Sh. Prem Raj, Lect(History) who is under transfer from GSSS Karyuni(Chamba) to GSSS Guwan(Chamba) is hereby adjusted at GSSS Sechunala(P)(Chamba) against vacancy without TTA/JT. Hence the representation stands disposed of. Directorate of School Education
