Whereas, Sh. Surjinder Kumar Lect.(SN)Pol.Science who is under

orders of transfer from GSSS Durgella (KGR) to GSSS (B) Pragpur(KGR) vice Smt. Anupam Kumari Lect./Lect. Pol.Science & vice versa, with TTA/JT issued vide this office order dated 11.11.2025, with the prior approval of competent authority. Feeling aggrieved Sh. Surjinder Kumar Lect.(SN) Pol.Science has filed CWP No.17957/2025 before the Hon'ble High Court against this transfer orders. This case was listed before the Hon'ble High Court on 19.11.2025 when the case was disposed of with the following directions:-

"Though having taken note of the fact that petitioner has already completed normal tenure at present place of posting, there appears to be no reason for this Court to interfere in the impugned transfer order, however, having taken note of the fact that petitioner shall be retiring within two years and two months coupled with the fact that Transfer Policy, enables an employee nearing retirement to seek transfer/adjustment to one of the stations of choice, this Court without going into the merits of the case, deems it fit to dispose of the present petition reserving liberty to the petitioner to file representation to the competent authority within one week, which in turn shall be decided by the competent authority expeditiously, preferably, within ten days thereafter. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy formulated by the Government of Himachal Pradesh, as detailed herein above.

Since it is apparent from the record that petitioner shall be retiring within two years and two months, meaning thereby, after expiry of two months from the date of passing of the impugned order, he shall otherwise be entitled to claim transfer/adjustment at a convenient place on account of his having remained less than two years to retire, no prejudice if any, shall be caused to either of the parties in case prayer made at this juncture on the afore ground is consider and decide by the competent authority so that multiple litigations are avoided. Till the time, representation, if any, filed by the petitioner in terms of instant order is decided, he shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

And whereas, upon passing of above directions, petitioner was called for personal hearing on 09.12.2025 and during the course of hearing he has requested that he is unable to join at transferred station i.e. GSSS (B) Pragpur(KGR), as his is on the verge of retirement in January 2028 with less than two year and two months of service remaining and due to his adverse family circumstances, as his mother is 75 years old and requires continuous care and medical support, and further requested to adjust him at GSSS Nandrool, GSSS Paddar, GSSS Kothar Ranital Distt. Kangra against vacancy.

And whereas, as per direction passed by the Hon'ble High Court as mentioned above, while examined his representation, it is also observed that petitioner is serving in soft area for last 18 years within the radius of 30 Kms moreover where he has been transferred is also soft area as well as his home district. However, as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and his transfer orders dated 11.11.2025 shall stand.

With these observationns, representation stands disposed of.

ORDER

Whereas, Sh. Rakesh Kumar, Lect./Lect.(SN) Commerce presently posted at GSSS Khatnol (SML) w.e.f. 21.08.2025 has filed CWP No. 17986/2025 before the Hon'ble High Court regarding to direct the respondent to decide his pending representation wherein he has seeking his transfer from GSSS Khatnol (Shimla) to his choice of station i.e. GSSS (G) Lakkar Bazar (Shimla) against vacancy, on medical ground.

The case was listed before the Hon'ble Court on 20.11.2025 when the case was disposed of with the following directions:-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 10.11.2025 (Annexure P-2) in accordance with law and applicable transfer policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

And whereas, to settle the said court case petitioner was called for personal hearing on 09.12.2025. During the course of hearing petitioner has requested that he is suffered from major heart attack and he was admitted in IGMC Shimla and his wife is also a Centeral Govt. Employee at and working as Chief Technical Officer in HFRI, Sargheen (Shimla) and and his present station is about 50 Km away from his residence. Hence kept in view of his medical problems he may kindly be transfer to GSSS (G) Lakkar Bazar (Shimla) against vacancy, on medical ground.

And whereas, that the matter has been examined and found that one post of Lect. Commerce is lying vacant at GSSS (G) Lakkar Bazar (Shimla) but it is not feasible to transfer Sh. Rakesh Kumar Lect. Commerce from GSSS Khatnol (SML) to his choice of station due to having very very short stay w.e.f. 22.8.2025. However, and as per "Comprehensive Guiding Principles-2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected.

With these observations, representation stands disposed of.
