**ORDER**

In the matter of: CWP No. 16183/2025- Sh. Rakesh Sharma, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Rakesh Sharma, TGT(NM) presently working in GSSS(B) Una, Distt. Una has filed CWP No.16183/2025 titled as Rakesh Sharma Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS(B) Una to one of the stations of his choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 15.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of the fact that wife of the petitioner is also Government employee and at present, she is working as JBT at GPS Sai, BEEO Hamirpur. Pending application(s), if any, also stands disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 30.10.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS(B) Una to GHS Thatwani u/c GSSS Parol, Distt. Hamirpur being couple case vice Sh. Rajender Kumar, TGT(NM) on mutual basis.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS(B) Una on regular basis and Sh. Rajinder Kumar, TGT(NM) has been working in GHS Tathwani u/c GSSS Dera Parol, Distt. Hamirpur since 21.09.2022 and has complete his normal tenure of three years. Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS(B) Una to GHS Thatwani u/c GSSS Parol, Distt. Hamirpur vice Sh. Rajender Kumar, TGT(NM) and Sh. Rajender Kumar, TGT(NM) is hereby further transferred to GHS Krishna Nagar, Distt. Shimla, against vacancy without TTA/JT on his own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
