ORDER

In the matter of:

CWP No. 12185/2025-titled as Hem Singh (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Hem Singh, TGT (Med.) has filed CWP No. 12185/2025 titled as Hem Singh V/s. State of H.P. in the Hon'ble High Court, and seeking his transfer from GHS, Gurad Distt. Chamba (Sub cadre/hard area) either to GSSS, Karian a/v, on retirement, GHS, Rajera GMSSS, Bharian Kothi Any other school in the vicinity of Chamba Town. The case was listed before the Hon'ble High Court of H.P. on 28.07.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Since it is quite apparent from the pleading adduced on record that petitioner is working in a hard area for more than six years, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from hard area to soft area on his/her having completed normal tenure i.e. two winters and three summers, this Court sees no impediment in issuing directions to the respondents to consider and decide the pending representation of the petitioner (Annexure P-2) expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of observation made herein above as well as Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of."

As per the direction of the Hon'ble High Court the petitioner was called for personal hearing and attended the personnel hearing on 25.08.2025. Sh. Hem Singh, TGT (Med.) has requested to adjust him at GSSS, Karian on retirement, GHS, Rajera, GMSSS, Bharian Kothi or any other school in the vicinity of Chamba Town after completion of normal tenure at present place of posting.

From the perusal of record, it is found that Sh. Hem Singh, TGT (Med.) is working at GHS, Gurad (Sub cadre/hard area) District Chamba since 08.03.2019 and has completed normal tenure at his present place of posting. At present one post of TGT (Med.) is going to be vacate at GSSS, Karian Distt. Chamba due to retirement on dated 30.09.2025.

Keeping in view the position stated above, representation of the petitioner i.e. Sh. Hem Singh, TGT (Med.) is considered sympathetically and hereby transferred from GHS, Gurad Distt. Chamba to GSSS Karian Distt. Chamba, against vacancy being caused due to retirement of present incumbent on 30.09.2025, without TTA/JT on his own request. The representation of the petitioner is disposed of accordingly.
