## ORDER

In the matter of:

CWP No. 13861/2025- Smt. Asha Kumari, TGT(NM) Vs. State of H.P. and others.

· Whereas, Smt. Asha Kumari, TGT(NM) presently working in GSSS Seri Batwara, Distt. Mandi has filed CWP No.13861/2025 titled as Asha Kumari Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred at one of the stations of her choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 28.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Since petitioner has already completed normal tenure at present place of posting, coupled with the fact that there are adverse family circumstances in her family, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation of the petitioner (Annexure P-2) expeditiously, preferably within three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which enables an employee to seek transfer from one station to another on the ground of adverse family circumstances. Pending applications, if any, stand disposed of ."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GSSS Seri-Batwara, Distt. Mandi to GSSS Sadiana or GSSS Gharan or GMS Sadoh u/c GSSS Bharara, Distt. Mandi, against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Seri Batwara, Distt. Mandi since 03.03.2021 on regular basis and has completed her normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GSSS Sadiana, Distt. Mandi.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GSSS Seri Batwara, Distt. Mandi to GSSS Sadiana, Distt. Mandi, against vacancy without TTA/JT as per her request.

Therefore, the representation of the petitioner is disposed of after due consideration.
