ORDER

Whereas, Sh. Vijay Kumar, Lecturer (School-New) (English) who is presently postedat GSSS Dhar (Mandi) was filed CWP No. 9731/2025 before the Hon'ble High Court regarding seeking direction to the respondent to consider and decide his representation vide which he has sought his transfer from GSSS Dhar, Distt. Mandi to one of the stations of his choice on the grounds that as such he has completed his normal tenure at present place of posting and being his medical problems.

The case was listed before the Hon'ble Court on 17.06.2025 when the case was disposed of with the following directions:-

"Consequently, in view of the above, this Court without going into the medits of the case deems it fit to dispose of the present petition with direction to the competent authority to decide pending representation (Annexure P-1) having been filed by the petitioner, within two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of Clause 10 and 15(b) of the transfer policy. Pending applications, if any, also stand disposed of."

And whereas, as per the direction passed by the Hon'ble High Court on 17.6.2025, petitioner was called to appear in person on dated 07.07.2025. During the course of hearing, petitioner has requested that he is unable to continue serve at GSSS Dhar (Mandi) due to his medical problems as he is suffering from frequent knee pain, backache and sciatica pain as well as he has completed his normal tenure at present place of posting as such this station falls in rural area and it is difficult him to reach the school as the institution is more than 1 Km far from the main road and this distance is to be covered on foot. Hence, keeping in view his medical problems he may kindly be adjusted either at GBSSS Mandi or GSSS Urla, Distt. Mandi against vacancy.

And whereas, that the matter has been examined and found that although post is lying vacant at proposed stations but where petitioner is presently posted is soft area and students enrolment is 70 in 10+1 & 10+2 class and as per "Comprehensive Guiding Principles-2013" for regulation the transfer of State Government employees it is clearly mentioned at Rule-12.1 that no government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenienceon.

Now therefore, after taking into the account of above discussed detailed facts and circumstances, a request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected.

With these observations, representation stand disposed of.

ORDER

Whereas, Smt. Nirmala Devi, DPE/ Lect. Physical Education has filed CWP No. 10665/2025 before the Hon'ble High Court against her transfer issued vide this office order dated 30.06.2025 on the ground that there is none to take care of her son, who at present is studying in Classs 11th at Dalhousi (Chamba) and his husband is also government employee who is posted at Pangi (Chamba).

The case was listed before the Hon'ble Court on 04.07.2025 when the case was disposed of with the following directions:-

"Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority within a period of two days, paying therein for her adjustment at a convenient station, enabling her to take care of her school going children, which in turn, shall be decided by the competent authority expeditiously, preferably within a period of ten 3 days, taking note of the fact that husband of the petitioner is also government employee and at present is posted at Pangi. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shallafford an opportunity of hearing to the petitioner and pass appropriate order," taking note of transfer policy framed by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer/adjustment at a convenient station on account of adverse family circumstances. Till the time representation, if any, filed by the petitioner within a period of two days, is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

And whereas, as per the direction passed by the Hon'ble High Court petitioner has submitted her representation on dated 05.07.2025 wherein she has requested that due to adverse family circumstances she is unable to join at GSSS Hatli (CBA) which is very far from her present station and her son is presently studying at GSSS Dalhousie (CBA) in 10+1 class and her husband is working a Clerk in PWD at Pangi (CBA) so it is difficult to leave her son alone or take him along during mid academic session, this would majorly affect the study of her son. Hence, keeping in view her adverse family circumstance she may kindly be adjusted either at GSSS Bathri/Bagdhar or Dalhousie, Distt. Chamba.

And whereas, that the matter has been examined and found that at present post is not lying vacant at proposed stations, however the officials working at these stations as DPE/ Lect. Phy. Education have already completed their normal stay. Hence, request of the petitioner is being allowed/considered to GSSS Bagdhar(Cba) vice present incumbent.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Smt. Nirmala Kumari, DPE/Lect. Phy. Education, who is under orders of transfer from GSSS Banikhet (CBA) to GSSS Hatli (CBA) is hereby suitably adjusted at GSSS Bagdhar (CBA) without TTA/JT vice Sh. Jagjeet Singh Thakur, DPE/ Lect. Phy. Education who is further transferred to GSSS Hatli (CBA) against vacancy with TTA/JT being a longer stayee.

With these observations, representation stands disposed of
