

OFFICE ORDER

In the matter of: CWP No. 20507/2025-titled as Suresh Kumar,Vs. State of H.P
& Others.

Whereas, Sh. Suresh Kumar, Lect. Chemistry preferred CWP No. 20507/2025 titled as Suresh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Killing, Distt. Mandi to nearby his native place in Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 24-12-2025 when the Hon'ble High Court has passed the following orders:-

3. " True it is that it is the sole prerogative of the employer to post an employee at a particular station, but once transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer from one station to other on medical grounds, coupled with the fact that perusal of the documents annexed with the petition, reveals that petitioner is suffering from heart ailment, this Court sees no impediment in issuing direction to the respondent to consider and decide the representation dated 22.11.2025 (Annexure P-2), of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order. Pending applications, if any, also stand disposed of."

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 16-01-2026. He attended the same and submitted his representation in this office on 16-01-2026, vide which he has requested that he may be transferred from GSSS Killing, Distt. Mandi to GBSSS Sundernagar, GSSS Kanaid, GSSS Mahadev, Distt. Mandi, H.P, against vacancy / against longer stayee, on medical grounds.

In the perusal of the record, it is found that the petitioner is working at GSSS Killing, Distt. Mandi, H.P since 21-09-2023 and has not completed his normal tenure at his present place of posting. At present the post of Lect. Chemistry are not lying vacant in any of the above said institutions mentioned by the petitioner. Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and stands disposed of.

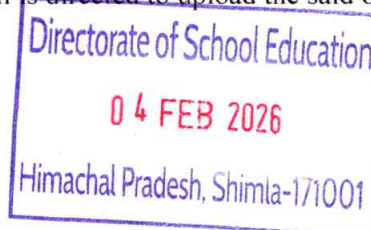
