ORDER

Whereas, Sh. Ramesh Kumar, Lecturer (School-New)(Economics), presently posted at GSSS Lohardi, Distt. Kangra, filed CWP No. 2618/2026 before the Hon'ble High Court for seeking direction to the respondent to decide his pending representation wherein he has request that he has completed his normal tenure in hard area and seeking his transfer to one of the stations of his choice.

The case was listed before the Hon'ble Court on 6.3.2026 when the case was disposed of with the following directions:-

"This writ petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided by the Competent Authority in light of the averments made therein within a period of eight weeks from today. Pending miscellaneous application(s), if any also stand disposed of accordingly."

And whereas, in compliance with the Hon'ble High Court directions, the petitioner was granted a personal hearing on 24.03.2026. During the course of hearing, the petitioner submitted that he is posted in GSSS Lohardi (Kangra), which falls in a hard area, and completed his normal tenure there. He requested a transfer to one of the stations of his choice, i.e. GSSS Sakri (Kangra) against vacancy being caused due to retirement of present incumbent on 31.3.2026 or GSSS Paprola/GSSS Gadiara/Andretta Distt. Kangra or GSSS Pandol, Distt. Mandi, on the basis of longer stay.

And whereas, the representation has been examined thoroughly in light of the existing Transfer Policy and administrative exigencies. Upon perusal of the service record, the following facts have emerged:


The petitioner is presently posted in a hard area, i.e. GSSS Lohardi (KGR), and has completed his normal tenure there. As per the Transfer Policy, he is liable for transfer to one of the stations of his choice. At present post, no post of Lecturer (Economics) is lying vacant at his preferred stations; however, the Lecturer (Economics) posted at GSSS Sakri (Bajjnath) (Kangra) is due to retire on 31.3.2026, and the petitioner can be adjusted there as per his request.

Now therefore, after careful consideration of the above mentioned facts, the representation of petitioner is considered sympathically, and the petitioner, i.e. Sh. Ramesh Kumar, Lecturer (School-New) (Economics), is hereby transferred from GSSS Lohardi (Kangra) to GSSS Sakri (Bajjnath) Distt. Kangra against vacancy being caused due to retirement of present incumbent on 31.03.2026, without TTA/JT, as per the petitioner's request. The representation stands disposed of accordingly.

Note:- These orders shall come into force on or after 01.04.2026.
