Whereas, Aman Singh, TGT (NM) preferred CWP No. 4129/2025 titled as Aman Singh, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Runpu, U/C GSSS Kinnu, Distt. Shimla, H.P to nearby his native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22-03-2025 when the Hon'ble High Court has passed the following orders:-

3. "Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while affording opportunity of hearing to the petitioner, shall also take note of the transfer policy formulated by the Government of Himachal Pradesh, which provides for transfer of an employee from hard/rural area to soft area after his/her having completed normal tenure at present place of posting and pass appropriate orders. Pending applications, if any, also stand disposed."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 26-04-2025. He attended the same and submitted his representation in this office on 26-04-2025, vide which He has requested that He may be transfer from Runpu, U/C GSSS Kinnu, Distt. Shimla, H.P to nearby his native place in Distt. Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms.

From perusal of record, it has been found that the petitioner has been working at GMS Runpu, U/C GSSS Kinnu, Distt. Shimla, H.P since 21-02-2022 and has completed his normal tenure at present place of posting. One Sh. Vijay Kumar, TGT(NM) is working in GSSS Lagru, Distt. Kangra, H.P. since 04-07-2022 and has almost completed three years stay there. The petitioner has given willingness for his transfer to the aforesaid school against longer stay/ longer stay by clubbing his/her previous stay within radius of 30 Kms. Whereas, Sh. Ankush Kumar, TGT (NM) preferred CWP No. 7843/2025 titled as Ankush Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Prabha u/c GSSS Bagheigarh, Distt. Chamba to the station nearby his native place in Distt. Bilaspur, against vacancy/ longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14.05.2025 when the Hon'ble High Court has passed the following orders:-

"4 Since, it is quite apparent from the pleadings adduced on record that petitioner has already completed normal tenure of posting at present place of posting, coupled with the fact that transfer policy formulated by Government of Himachal Pradesh, enables an employee to seek transfer after his/her having completed normal tenure of posting at present place of posting, this Court without going into the merits of the case, deems it fit to disposed of the same with a direction to the respondents to consider and decide the representation dated 03.03.2025(Annexure P-3)of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy which enables an employee to seek transfer on the ground of adverse family circumstances. Pending applications, if any, also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 02.06.2025. He has attended the same and submitted his representation in this office on 02.06.2025 vide which he has requested that he has completed normal tenure at his present place of posting i.e GMS Prabha u/c GSSS Bagheigarh, Distt. Chamba, H.P and he further requested that he may be transferred/adjusted in Distt. Bilaspur, against vacancy/ longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working in GMS Prabha u/c GSSS Bagheigarh, Distt. Chamba, W.e.f. 26.02.2022 and has completed three years stay at present place of posting. One Sh. Ravinder Kumar TGT (NM) is working in GHS Kharli u/c GSSS Dhani, Distt. Bilaspur since 02.09.2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay/ clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted without TTA from GMS Prabha u/c GSSS Bagheigarh, Distt. Whereas, Praveen Kumar, TGT (NM) preferred CWP No. 9632/2025 titled as Praveen Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Ghial, Distt. Bilaspur to GMS Bhagar Chowki, U/C GSSS Dhabas, Distt. Shimla, H.P.The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 11-06-2025 when the Hon'ble High Court has passed the following orders:-

7. "Leaving all questions open and after taking into account the entirety of facts and circumstances, this Court disposes of the instant petition in the following terms:- (i) Petitioner is permitted to make a representation to Respondent No.2-Director, School Education, Himachal Pradesh within three days from today; (ii) In case, any such representation is made, Respondent No.2 is directed to consider/examine the same in accordance with Transfer Policy, including Clause 5.4, in accordance with law; after hearing the petitioner and Respondent No.6 [if he so desires] on or before 21.6.2025; (iii) Safeguard, the Respondent No.6; this Court directs that Respondents shall not compel the petitioner to join the transferred station till the decision of the representation; and in such an eventuality, the petitioner is free to avail leave of the kind due. (iv) No order as to costs. In aforesaid terms, the instant writ petition as well as all pending miscellaneous application(s), if any shall stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office on 16-06-2025, vide which He has requested that He may be adjusted at Distt. Mandi /Bilaspur / Sirmour , H.P. against vacancy/ against longer stay being couple case .

From perusal of record, it has been found that the petitioner has been working at GHS Ghial, Distt. Bilaspur, H.P and under transfer to GMS Bhagar Chowki, U/C GSSS Dhabas, Distt. Shimla, H.P. At present the post of TGT(NM) is lying vacant in GHS Nei Nati, Distt. Sirmour, H.P. and 43 students are studying in GHS, Nei Nati, Distt. Sirmour. The petitioner has given willingness for his adjustment to the aforesaid school against vacancy. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and He is hereby adjusted at GHS Nei Nati, Distt.
