ORDER

In the matter of: CWP No. 15896/2025-titled as Ashwani Kumar (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Ashwani Kumar, TGT (Med.) has filed CWP No. 15896/2025 titled as Ashwani Kumar V/s. State of H.P. in the Hon'ble High Court, and seeking his transfer from GHS, Bhamnoli Distt Shimla to GSSS, Brang Distt. (Mandi) against vacancy. The case was listed before the Hon'ble High Court of H.P. on 09.10.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*"Looking to the limied grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law, within a period of four weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."*

As per the directions of the Hon'ble High Court, the petitioner was scheduled for a personal hearing on 15.11.2025. The petitioner attended the personal hearing on scheduled date and time. During personal hearing he has requested to adjust him at GSSS, Brang Distt. (Mandi) against vacancy.

From the perusal of record, it is found that Sh. Ashwani Kumar, TGT (Med.) is working in GHS, Bhamnoli Distt. (Sml.) since 03.05.2019 and has completed normal tenure at his present place of posting. At present one post of TGT (Med.) is lying vacant at GSSS, Brang Distt. (Mandi) .

Keeping in view the position stated above, representation of the petitioner i.e Sh. Ashwani Kumar, TGT (Med.) is considered sympathetically and hereby transferred from GHS, Bhamnoli Distt. Shimla to GSSS, Brang Distt. (Mandi) against vacancy, without TTA/JT on his own request. The representation of the petitioner is disposed of accordingly.
