ORDER

Whereas, Sh. Ravinder Singh, DPE/Lect. Physical Education presently posted at GSSS Samej (Kullu) (Hard Area) w.e.f. 20.09.2021 has filed CWP No. 18618/2025 before the Hon'ble High Court regarding to direct the respondent to decide his pending representation wherein he has seeking his transfer from GSSS Samej (Kullu) to his choice of station station i.e. GSSS Masli (Shimla), Dhamwari (Shimla)/Saribasa (Shimla)/Gaonsari (Shimla), on compassionate ground as well as he has completed his normal tenure in hard area.

The case was listed before the Hon'ble Court on 27.11.2025 when the case was disposed of with the following directions:-

“This case was listed before the Hon'ble High Court on 09.12.2025 when Petitioner is serving as DPE at Government Senior Secondary School, Samej, Tehsil Nirmand, District Kullu, H.P. stated to be a hard area in terms of applicable transfer policy. Petitioner's grievance is that on completion of requisite tenure at aforesaid station, he preferred a representation to respondent No.2 seeking transfer to soft area of his preference. The said representation dated 26.10.2025 (Annexure P-1) has still not been considered and decided by the competent authority till date. Learned counsel for the petitioner submits that petitioner would be satisfied in case the respondents are directed to consider and decide the aforesaid representation within a fixed time schedule. Learned Additional Advocate General is not averse to this prayer.

Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 26.10.2025 (Annexure P-1) in accordance with law and applicable transfer policy, within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.”

And whereas, to settle the said court case petitioner was called for personal hearing on 16.01.2026. During the course of hearing petitioner has requested that he has completed his normal tenure at GSSS Samej (Kullu) which falls in hard area and as his aged parents, both around 88 years old and there is no other family member except him to look after them and their health conditions demand constant care and attention. Hence keeping in view of his adverse family circumstances and completion of stay in hard are he may kindly be transfer to one of station of his choice.

And whereas, that the matter has been examined and found that at present post of DPE/Lect. Phy. Education is not lying vacant within the radius of 30 Kms as desired by the petitioner, however post of DPE is lying vacant at GSSS Tharola (SML) which is in soft area. However, he is completed his normal tenure in hard area and is liable to transfer in soft area.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Sh. Ravinder Singh, DPE Lect Phy. Education, posted at GSSS Samej (KLU) is hereby transferred to GSSS Tharola (Shimla) against vacancy which is soft area and as well as his home district.

With these observations, representation stands disposed of.
