In the matter of:CWP.No.13945/2025- titled as Jatinder Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Jatinder Kumar, TGT(NM) presently working in GSSS Dadriyara, Distt. Shimla has filed CWP. No.13945/2025 titled as Jatinder Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 29.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order:-

"Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order. Pending applications, if any, also stand disposed of".

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 15.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Dadriyara, Distt. Chamba to GSSS Jassai or GMS Jagani u/c GSSS Jassai or GHS Menjha or GMS Dohb or GMS Patti or GSSS Gheen or GMS Talla or GSSS Bhoura or GSSS Atyaladai, Distt. Kangra against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Dadriyara, Distt. Chamba since 24.12.2021 which is a soft area and he has completed his normal tenure at his present place of posting. The petitioner is a TGT(NM) which comes under State cadre post and can be posted anywhere in the state as per requirement. The petitioner in his representation has specified for his adjustment in GSSS Jassai or GMS Jagani u/c GSSS Jassai or GHS Menjha or GMS Dohb or GMS Patti or GSSS Gheen or GMS Talla or GSSS Bhoura or GSSS Atyaladai, Distt. Kangra. However, as per Comprehensive Guidelines Principles-2013 there is no such provision that allows a government employee serving in soft area to specify stations of his choice for adjustment.

Therefore, keeping in view the position stated above, request made by Sh. Jatinder Kumar, TGT(NM) cannot be considered at this stage due to mid -academic session and the same is hereby rejected. The representation of the petitioner is disposed of after due consideration.
