## **ORDER**

In the matter of:

CWP No. 16603/2025- titled as Rakesh Kumar Vs. State of H.P.

and others.

Whereas, Rakesh Kumar, TGT (NM) presently working in GMS Jaswi u/c GSSS Koti Bounch, Distt. Sirmour has filed CWP. No. 16603/2025- titled as Rakesh Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Jaswi u/c GSSS Koti Bounch, Distt. Sirmour to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 27.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Though this Court finds no reason to differ with the aforesaid submission of Mr. Ravi Chauhan, learned Deputy Advocate General, but since Transfer Policy itself provides for minimum tenure of three years at one station, coupled with the fact that petitioner has already completed normal tenure at present place of posting, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation of the petitioner (Annexure P-2) expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.11.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Jaswi u/c GSSS Koti Bounch, Distt. Sirmour to GMS Kathiara u/c GSSS Garli or GSSS Bilaspur or GSSS Sakari or GSSS Haripur or GSSS Guler, Distt. Kangra against longer stayee or against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working at GHS Jaswi u/c GSSS Koti Bounch, Distt. Sirmour (Sub Cadre) since 13.06.2022 and completed his normal tenure at this station. At present, one post of TGT (NM) is lying vacant at GMS Kathiara u/c GSSS Garli, Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GHS Jaswi u/c GSSS Koti Bounch, Distt. Sirmour to GMS Kathiara u/c GSSS Garli, Distt. Kangra. against vacancy without TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
