Whereas, Sh. Sher Singh, TGT (NM) presently working in GSSS Sarni, Distt. Mandi (Hard area) has filed CWP No. 14306/2025 titled as Sher Singh, TGT (NM) Vs. State of H.P & others, before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Sarni, Distt. Mandi to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 30.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Looking to the nature of the grievance raised in this writ petition, it would in the interest of justice to direct 1Whether reporters of Local Papers may be allowed to see the judgment? Competent Authority to consider and decide the aforesaid representation (Annexure P-1) of the petitioner in accordance with law and as per applicable policy within a period of three weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner. The writ petition stands disposed of in the above terms. All pending miscellaneous application(s), if any, to also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Sarni, Distt. Mandi (Hard area) to GMS Ropi u/c GSSS Padhar or GMS Gawahan u/c GSS Padhar or GSSS Siun or GMS Ghatasani u/c GSSS Gumma, Distt. Mandi against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working at GSSS Sarni, Distt. Mandi (Hard area) since 20.07.2022 and has completed his normal tenure. One, Sh. Ishwar Dass has been working in GMS Ropi u/c GSSS Padhar, Distt. Mandi since 02.07.2021 and has completed his normal tenure of three years in present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GSSS Sarni to GMS Ropi u/c GSSS Padhar, Distt. Mandi without TTA/JT vice Sh. Ishwar Dass, TGT (NM) (as he has been working there since 02.07.2021) vice versa with TTA/JT. ented of miles week

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
