The Petitioner Smt. Sushma Devi, TGT(Med) filed CWP No. 9493/2025

titled as, Smt. Sushma Devi, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS, Uttrapur U/c GMSSS Jaisinghpur Distt. (Kangra.) due to merger of the school. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 01.08.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Though having taken note of the fact that petitioner has been transferred at a distance of 12 kilometers from the present place of posting, this Court sees no reason to interfere with the impugned transfer order, but while disposing of the petition, in order to balance equities, deems it fit to order that in the event of petitioner being declared surplus, if any, on account of merger of the Government High School, Uttrapur, District Kangra with GMSSS, Jaisinghpur, she shall be given posting at nearby station. Ordered accordinglyPending applications, if any also stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 11.11.2025 with the fresh representation. She has requested to adjust her at nearby station after merging the school.

After perusal of the relevant records, it is revealed that the petitioner has been serving at GHS, Uttrapur, Distt. Kangra, since 05.08.2025. At present, GHS Uttrapur is functioning. In the event of the school's merger, she shall be posted to a nearby station, subject to the availability of a vacancy at that time.

Accordingly, the representation of the petitioner is disposed of after due consideration.

Smt. Kavita Kumari, TGT (Med.) has filed CWP No. 15845/2025 titled as Kavita Kumari V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from GSSS. Ropa Distt. (Mandi) to GHS, Panjan u/c GSSS, Joginder Nagar Distt. (Mandi)/GSSS, Kuthera/GSSS, Baijnath/GSSS, Aju/GSSS, Joginder Nagar Distt. (Mandi) against vacancy. The case was listed before the Hon'ble High Court of H.P. on 27.08.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Since it is quite apparent from the pleadings as well as documents adduced on record that petitioner has already completed normal tenure at present place of posting. Which is notified to ba a hard area, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from hard area to soft area on his/her having completed normal tenure i.e. two winters and three summers, this Court sees no impediment in issuing directions to the respondents to consider and decide the pednding representation of the petitioner (Annexure P-1) expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of."

As per the directions of the Hon'ble High Court, the petitioner was scheduled for a personal hearing on 11.11.2025. The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested to adjust her at GHS, Panjan u/c GSSS, Joginder Nagar Distt. (Mandi)/GSSS, Kuthera/GSSS, Baijnath/GSSS, Aju/GSSS, Joginder Nagar Distt. (Mandi) against vacancy.

From the perusal of record, it is found that Smt. Kavita Kumari, TGT (Med.) is working in GSSS, Ropa Distt. (Mandi.) since February 2022 which falls in sub cadre/hard area and has completed normal tenure at her present place of posting. At present one post of TGT (Med.) is lying vacant at GHS, Panjan u/c GSSS, Joginder Nagar Distt. (Mandi) .

Keeping in view the position stated above, representation of the petitioner i.e. Smt. Kavita Kumari, TGT (Med.) is considered sympathetically and hereby transferred from GSSS, Ropa Distt. (Mandi.) to GHS, Papian u/c GSSS, Joginder Nagar Distt. (Mandi) against vacancy, without TTA/JT on her own request The representation of that betitioner is disposed of accordingly.
