**ORDER**

In the matter of: CWP No. 12780/2025- Sh. Sujan Singh, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Sujan Singh, TGT(NM) previously working in GSSS Guglara, Distt. Kangra has filed CWP No. 12780/2025 titled as Sh. Sujan Singh Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 07.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

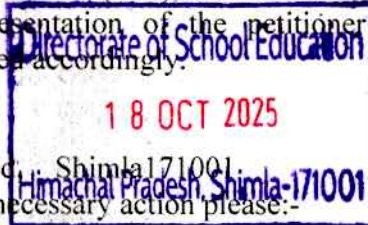
*"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing the respondents/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law and applicable transfer policy, within a period of one week from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 03.09.2025 but the petitioner did not appear. However, another opportunity was granted to the petitioner on 15.09.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Harnota or GHS Larth or GGSSS Jawali or GSSS Sidhpur Ghar, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMSSS Guglara, Distt. Kangra to GMSSS Bairagarh, Distt. Chamba, vide order dated 5.5.2025 with the prior approval of the competent authority. The petitioner had already served in hard area GSSS Thalli Tehsil Churah, Distt. Chamba w.e.f 13.11.2019 to 2.3.2022. One, Smt. Seema Devi, TGT(NM) has been working in GSSS Harnota, Distt. Kangra since 14.09.2022 and has completed her normal tenure of three years at her present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted without TTA/JT at GSSS Harnota, Distt. Kangra vice Smt. Seema Devi, TGT(NM), and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
