ORDER

In the matter of:- CWP No. 7415/2023-titled as Pavan Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which seeking his transfer from GSSS Pekha tehsil Chirgaon district Shimla to one of the station of his choice (Soft area). Earlier petitioner representation was rejected on dated 26.7.2023. Now, the present CWP No. 7415/2025 was listed before the Hon'ble High Court of H.P. on 24-06-2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"....Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders, taking note of Transfer Policy, formulated by the Government of Himachal Pradesh, as detailed hereinabove. It is made clear that prayer of the petitioner shall not be rejected merely on the ground that there is no vacancy available, rather in that situation, if required, person with the longer stay, can be transferred, so that petitioner is not again compelled to approach this Court for redressal of his grievance, which otherwise ought to have been redressed by the Department concerned, in terms of Transfer Policy, formulated by the Government of Himachal Pradesh."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 14.08.2025 and appeared before the undersigned on scheduled date. The petitioner has stated that he has completed normal tenure at present place of posting and he is single caretaker of his family and requested to transfer/adjustment either at GSSS Dumehar, GHS Gahar u/c GSSS Dadhol/GSSS Barota/GMS Bari Chhajoli u/c GSSS Dangar/GSSS Salaon Distt. Bilaspur.

From the perusal of record, it is found that Sh. Pavan Kumar, TGT (Arts) is working at GSSS Pekha tehsil Chirgaon district Shimla since 07.10.2017 and has completed his normal tenure at present place of posting. At present post of TGT (Arts) is lying vacant at GSSS Salaon Distt. Bilaspur wherein 47 students are enrolled.

In view of above narrated circumstances, the representation of petitioner has been considered sympathically and the petitioner i.e. Sh. Pavan Kumar, TGT (Arts) is hereby transferred/adjusted from GSSS Pekha tehsil Chirgaon district Shimla to GSSS Salaon Distt. Bilaspur against vacancy (without TTA/JT). The representation of the petitioner in the present CWP stands disposed of. All the concerned be intimated accordingly.
