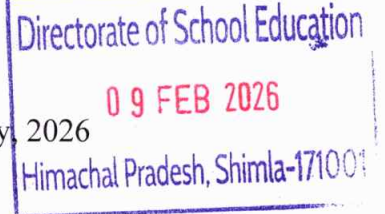

ORDER

In the matter of:- CWP No. 21155/2025-titled as Bhim Singh, TGT (Arts) V/s. State of HP.

The petitioner Sh. Bhim Singh has filed present CWP No. 21155 of 2025 in the Hon'ble High Court vide which sought his transfer from GSSS Sarahan Distt. Kullu to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 31.12.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 30-01-2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Bhim Singh, TGT (Arts), submitted fresh representation and stated that he is working at GSSS Sarahan Distt. Kullu so that requested for transfer/adjustment at GHS Tunna u/c GSSS Dhangiarra or GSSS Dhangiarra Distt. Mandi, on account of completion of normal tenure.

From the perusal of the record, it is found that Sh. Bhim Singh, TGT (Arts), has been working at from GSSS Sarahan Distt. Kullu since 15.10.2022 and he has completed his normal tenure at present place of posting wherein 126 students are enrolled. Further, at present one post of TGT (Arts) is lying vacant at GSSS Dhangiarra Distt. Mandi wherein 135 students are enrolled, which also falls within the choice station of the petitioner.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Sh. Bhim Singh, TGT (Arts) posted at GSSS Sarahan Distt. Kullu is hereby transferred/adjusted at GSSS Dhangiarra Distt. Mandi against vacancy without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.

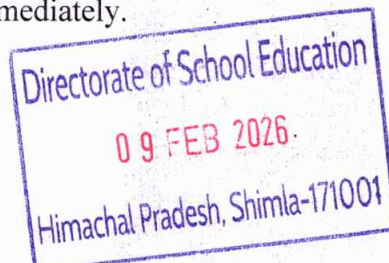
