ORDER

In the matter of: CWP No. 58/2026- Sh. Vishal Sharma, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Vishal Sharma, TGT(NM) presently working in GMS Juri u/c GSSS Charda, Distt. Chamba has filed CWP No.58/2026 titled as Sh. Vishal Sharma Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Juri u/c GSSS Charda, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 05.01.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

“Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law, within a period of four weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of.”

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.02.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Juri u/c GSSS Charda, Distt. Chamba to GSSS Parour or GHS Arla or GSSS Purba or GMS Peera u/c GSSS Rajhoon or GMS Lahar Thakra u/c GSSS Rajhoon, Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Juri u/c GSSS Charda, Distt. Chamba since 20.01.2023 and has completed his normal tenure of three years. One, Sh. Kuldeep Kumar, TGT(NM) has been working in GMS Peera u/c GSSS Rajhoon, Distt. Kangra since 21.03.2022.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Juri u/c GSSS Charda, Distt. Chamba to GMS Peera u/c GSSS Rajhoon, Distt. Kangra vice Sh. Kuldeep Kumar, TGT(NM), and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
