Subject: - Instructions regarding Expenditure on Court Orders.

Sir,

It has come to the notice that Departments are incurring expenditure on court directions from available budget on voted side. The expenditure on court directions/decrees is required to be undertaken as Charged expenditure which has clearly been specified under Article 202(3)(e) of the Constitution of India. Besides, there is huge financial/recurring liability involved in some court cases which adversely affects the resources and priorities of the Government. It has, therefore, been decided that:-

1. The expenditure on court directions/decrees be undertaken from Charged provisions as has been specified under Article 202(3)(e) of the Constitution of India. Expenditure from voted provision on such items is clear cut violation of this Article.
2. If appropriate provision for charged expenditure is not available in budget estimates, the administrative department may take up the matter with Finance Department for providing funds to satisfy court orders as Charged Expenditure.
