ORDER

Whereas, the petitioner namely Smt.Savita Negi Lect.(History) is working at GSSS Sauga Kando (Smr) w.e.f 04.04.2022 and completed her normal stay. She has filed CWP No. 16074/2025 titled as Savita Negi vs State of HP. This petition was listed on 13.10.2025 when the same was finally disposed with the directions to respondents as under:-

Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondents /Competent Authority to consider and decide the aforesaid representation of the petitioner in accordance with law and as per applicable notification/policy within a period of three weeks from today. The decision so taken be also communicated to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of.

And whereas, upon passing of the above direction, the representation of petitioner has been pursued and examined and it has been observed that she has requested for her adjustment at GSSS Shivpur (Sirmour) against vacancy being caused due to retirement of present incumbent.

And whereas, in compliance of Hon'ble High Court order dated 13.10.2025, the petitioner was called for personal hearing on 01.11.2025 and was present on this date. During the course of hearing petitioner has pleaded that she is under treatment from PGI, Chandigarh & Indira Fertility and IVF Centre Dehradoon, Uttarakhand for some critical Gynecological issues for last four years, in this matter, the petitioner may be adjusted at GSSS Shivpur (Sirmour) against vacancy after retirement of present incumbent.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner has been considered and allowed. The petitioner i.e Smt.Savita Negi Lect.(History) is being transferred from GSSS Sauga Kando (Smr) to GSSS Shivpur (Smr) against vacancy due to retirement of present incumbent on 31.03.2026 as per her request on medical ground with the condition that these orders shall come into force on or after 01.04.2026. Hence representation stands disposed of.
