State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Kangos, Distt. Kinnaur (Tribal Area) to one of the stations of his choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 21.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing the respondents/competent authority to consider and decide the aforesaid representation of the petitioner dated 21.02.2025 (Annexure P-3) in accordance with law and applicable transfer policy within a period of three weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Kangos, Distt. Kinnaur (Tribal Area) to GMS Ropa kale Amb u/c GSSS Kakriar or GSSS Sohari or GSSS Didwin or GSSS Biar or GSSS Barsar or GSSS Patta, Distt. Hamirpur.

After perusal of the relevant record, it is revealed that the petitioner has been working GHS Kangos, Distt. Kinnaur since 18.02.2022. Though the said teacher has completed his normal tenure but at present vacancies are not available as well as no longer stayee in GMS Ropa kale Amb u/c GSSS Kakriar or GSSS Didwin or GSSS Biar or GSSS Barsar or GSSS Patta, Distt. Hamirpur. One Sh. Rajneesh Kanwar, TGT (NM) has been working in GSSS Sohari, Distt. Hamirpur and has completed his normal tenure within the radius of 30 KM but he had already served Tribal area. Now, in view of the position as stated above the representation made by the petitioner will be consider at the time of promotion TGT to Lecturer/Headmaster in near future and petitioner will be transferred from GHS Kangos, Distt. Kinnaur to soft area against vacant post which will be arise by the promotion of TGTs on the availability of the vacancies. The representation is disposed of accordingly.

Whereas, Sh. Shammi Banyal, TGT (NM) presently working in GSSS Dharmpur Madhan, Distt. Shimla CWP. No. 4127/2025- titled as Shammi Banyal, TGT (NM), Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Dharmpur Madhan, Distt. Shimla to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 22.03.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

3. Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while affording opportunity of hearing to the petitioner, shall also take note of the transfer policy formulated by the Government of Himachal Pradesh, which provides for transfer of an employee from hard/rural area to soft area after his/her having completed normal tenure at present place of posting and pass appropriate orders. Pending applications, if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 26.04.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Sahaura or GHS Mumta u/c GSSS Samloti or GMS Sadarpur u/c GSSS Rajiana or GMS Salwana u/c GSSS Salol or GHS Jheol u/c GSSS Mandal or GSSS Zamanabad or GHS Dehriyan u/c GSSS Tiara or GSSS Salol, Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Dharmpur Madhan, Distt. Shimla since 21.02.2022. Though the said teacher has completed his normal tenure of three years at GSSS Dharmpur Madhan, Distt. Shimla but at present 83 students are studying there. Keeping in view the studies of the students studying at GSSS Dharmpur Madhan, Distt. Shimla it shall not be feasible to transfer the petitioner because in the absence of TGT (NM) the studies of students, will be affected adversely. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
