Whereas, Sh. Maneel Kumar, TGT (NM) preferred in CWP No. 2452/2025 titled as Maneel Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Deothi (Balsan), Distt. Shimla, H.P. to nearby home station in Distt. Bilaspur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-02-2025, when the Hon'ble High Court has passed the following orders:-

7. "Accordingly, in the interim, this Court, permits the petitioner to make a fresh representation within one week in trems of Clause 16.1 of the Existing Transfer policy, which shall be examined afresh by respondent No. 2- Director, Elementary Education, Himachal Pradesh, Shimla and without discriminiating the petitioner, and to pass appropriate orders within one week thereafter and not later than 07-03-2025, in accordance with law, after affording a personal hearing the petitioner (Maneel Kumar). till the decision of representation the post of TGT(NM) in GSSS Barota, District Bilaspur, shall remain vacant till next date of hearing. List the matter before appropriate Banch on 11-03-2025."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-03-2025. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting at GSSS Deothi (Balson), Distt. Shimla, H.P and he may be transferred to nearby native place in Distt. Bilaspur, H.P., against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Deothi (balson), Distt. Shimla, H.P. since, 12-03-2019 and has completed his normal tenure of three years at his present place of posting. One Sh. Rajinder Kumar, TGT(NM) is working in GSSS Kuthera, Distt. Bilaspur, H.P. since 04-10-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby transferred without TTA/JT from GSSS Deothi (Balson) Distt. Shimla, H.P. to GSSS Kuthera, Distt. Bilaspur, H.P. vice Sh. Rajinder Kumar, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Rajinder Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
