**ORDER**

**Whereas**, the petitioner in CWP No. 11535/2025 titled as Ranjit Singh Vs State of H.P. & others have been appointed on contract basis various years on fixed contractual emoluments equivalent to minimum of pay band plus grade pay and have further been regularized. Now they have filed court case that after issuance of notification dated 3<sup>rd</sup> January, 2022, the pay band on which they were offered appointment on contract basis should be revised w.e.f. 01.01.2016 at par with regular employees.

**Whereas**, the contract salaries in r/o all the contract employees are regulated by Finance Department and on 03-01-2022 State of HP notified Revised Pay Scale Rules-2022 and these rules were made applicable for regular employees of the State w.e.f. 01-01-2016.

**Whereas**, revised emoluments for contract employees were notified and made applicable w.e.f. 01-01-2022 and contract employees are fixed @ 60% of minimum of pay scale (at the lowest grade, in the regular pay scale). Further, the notification for the grant of arrears on account of pay revision is issued on dated 17-09-2022 by the State of HP qua regular employees which was not applicable for contract period.

**Whereas**, the above said court case was listed in Hon'ble High Court on dated 18-07-2025 wherein it has been ordered as under:-

*"Consequently, in view of the above, the present petition is disposed of with a direction to the respondents to consider and decide the representation (Annexure P-4) of the petitioners in light of judgment, as detailed hereinabove, expeditiously, preferably within a period of four weeks. In case, petitioners are found to be similarly situate to the petitioners in the aforesaid judgment, they would be extended similar benefits. Needless to say, authority concerned while doing the needful in terms of the instant order shall afford an opportunity of hearing to the petitioners and pass speaking order thereupon. Pending applications, if any, also stand disposed of."*

**And whereas**, the judgment passed in CWP No. 8148/2022 titled as Yashwant Kumar & Ors. Vs State has not been implemented yet and the same has been assailed by Health Department way of filing of LPA.


**Now therefore** as CWP No. 8148/2022 titled as Yashwant Kumar Vs State has not attained finality and the LPA has been preferred by Health Department. Accordingly, the claim of the petitioners has been considered and rejected.
