

**OFFICE ORDER**

In the matter of: CWP No. 17929/2025-titled as Tek Chand, Vs. State of H.P & Others.

Whereas, Sh. Tek Chand, DEP/Lect. Phy. Education preferred CWP No. 17929/2025 titled as Tek Chand Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Danni, Distt. Kangra to nearby his native place in Distt. Chamba, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-11-2025 when the Hon'ble High Court has passed the following orders:-

*3. "Since it is quite apparent from the pleadings adduced on record by the petitioner, which is duly supported by an affidavit, that petitioner is about to retire in two years coupled with the fact that Transfer Policy enables an employee nearing retirement to seek transfer/adjustment to one of the stations of choice, this Court without going into the merits of the case, deems it fit to dispose of the present petition with direction to the respondents to consider and decide pending representation of the petitioner (Annexure P-4 Colly.), expeditiously, preferably, within three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy formulated by the Government of Himachal Pradesh, as detailed herein. Pending application(s), if any, also stands disposed of."*

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 09-12-2025. He attended the same and submitted his representation in this office on 09-11-2025, vide which he has requested that he is on verge of retirement on 30-06-2027 and he may be transferred from GSSS Danni, Distt. Kangra to native place in Distt. Chamba, H.P. against vacancy / longer stayee at 1. GSSS Dugli, 2. GSSS Kalhel, Distt. Chamba, against vacancy or longer stay.

In the perusal of the record, it is found that the petitioner was working at DIET Chamba, H.P and transfer to GSSS Danni, Distt. Kangra, H.P. Petitioner has joined at GSSS Danni on 27-06-2025 and has not completed his normal tenure at his present place of posting. At present the post of DPE/ Lect. Phy. Education are not lying vacant in any of the above said institutions mentioned by the petitioner. Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and stands disposed of.
