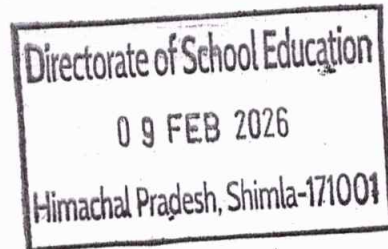

ORDER

Whereas, the petitioner namely Sh.Ashish Kumar Lect.(History) is working at GSSS Tikroo (Cba) w.e.f 07.04.2025 on contract basis. He has filed CWP No. 729/2026 titled as Ashish Kumar vs State of HP. This petition was listed on 08.01.2025 when the same has been finally disposed with the directions to respondents as under:-


“Though this Court finds no reason to differ with the aforesaid submission of Mr. Ravi Chauhan, learned Deputy Advocate General, but once Transfer Policy itself provides for minimum tenure of three years at one station, coupled with the fact that mother of the petitioner is not well, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation of the petitioner (Annexure P-4) expeditiously, preferably within four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of.”

And whereas, as per direction passed by Hon'ble High Court as above, the applicant was called to appear in this office for personal hearing on 03.02.2026 and he was present on this date. During the course of hearing petitioner has requested that he is unable to continue his services at present place of posting due to adverse family circumstances and further requested that he may kindly be adjusted one of the stations of his choice i.e GSSS Chhattar, GSSS Nangal, GSSS Khatiar, GSSS Hauri Devi, GSSS Diana against vacancy in Distt. Kangra.

And whereas, while examined his representation it is found that petitioner is presently working on contract basis w.e.f. 07.04.2025 and posted in soft area where enrollment of student is 57 but as per para number 4 contains in the department of personnel letter No.PER(AP)-C-B(2)-2/2024 dated 16.08.2024 and as per para 12.1 of “Comprehensive Guiding Principals-2013” the transfer of the Government employees, it is clearly mentioned that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/ transfer any employee anywhere in the state keeping in view of the administrative exigencies/ convenience; it is not feasible to transfer the petitioner.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner is being rejected and he will continue his services at GSSS Tikroo (Cba). Hence representation stands disposed of.

May inform the parties accordingly.
