In the matter of: CWP No 19672/2025- Sh.Chhotu Ram(DM) & oters Vs state of Vs. State of H.P. and others.

Whereas, Sh.Chhotu Ram(DM), presently working in GSSS Kunra (Bharmour), Distt. Chamba, H.P. has filed CWP. No. 19672/2025 titled as Chhotu Ram Vs. State of H.P. and others, regarding his transfer from GSSS Kunra (Bharmour), Distt. Chamba (Bharmour), Distt. Chamba, to Distt. Mandi, H.P under 5% quota. The case of the petitioner was listed before the Hon'ble High Court on 11.12.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

" Looking to the limited grievance of the petitioner, but without examining the merits of the matter, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 01.10.2025 (Annexure P-2) in accordance with law and applicable transfer policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 29th Dec.2025. The petitioner appeared before the undersigned on schedule date and time and heard in person. The petitioner has requested that he may kindly be transferred from GSSS Kunra (Bharmour), Distt. Chamba, to Distt. Mandi H.P against vacancy, under 5% quota inter district transfer policy.

From the perusal of the record, it reveals that the petitioner working in GSSS Kunra (Bharmour), Distt. Chamba since 16th Dec.2020 (Tribal/Hard area). At present, 447 posts of DM are sanctioned and out of these sanctioned posts about 125 posts of DM are lying vacant in District Chamba. At present 69 students are studying in GSSS Kunra (Bharmour) District Chamba. It is also pertinent to mention here that C&V cadre is a District cadre post. Before appointment the candidates apply in the District having hard & difficult areas where probability of their selection is high. As and when they complete their tenure they approach the Hon'ble High Court. If a single case is decided in favour of the petitioner, it may set a precedent (Analogy) leading to a substantial rise in similar cases. Moreover, transfer is not a matter of right to a teacher and it is not feasible to acceded to the request of the petitioner at present.

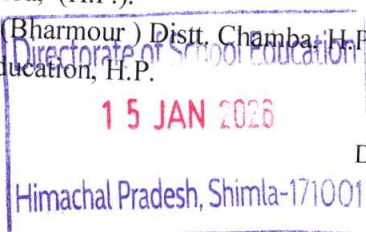
In view of facts stated above, the request of the petitioner cannot be acceded at present stage and her representation is hereby rejected and disposed of accordingly.
