ORDER

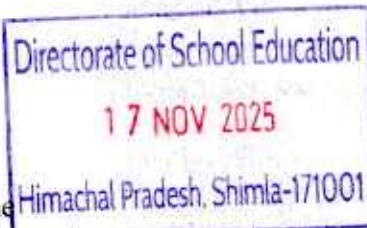
In the matter of:- CWP No. 13880/2025-titled as Rakesh Chand, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer at one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 28.08.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 14-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Rakesh Chand, TGT (Arts), submitted fresh representation and stated that he is working at GHS Mahipur u/c GSSS Bechar Ka Bagh Distt Sirmour and his wife is also working in this Education department as TGT Hindi and posted in Distt. Kangra further his children are studying in 11th and 7th class so that requested for transfer/adjustment at GSSS Jowar or GSSS Andoura or GSSS Kinnu or GSSS Charatgarh Distt. Una.

From the perusal of the record, it is found that Sh. Rakesh Chand, TGT (Arts), is posted at GHS Mahipur u/c GSSS Bechar Ka Bagh Distt Sirmour. At present (02) two posts of TGT (Arts) are lying vacant at GSSS Charatgarh Distt. Una, wherein about 108 students are enrolled, which also falls within the choice station of the petitioner.

Keeping in view the position stated above, representation of the petitioner is considered sympathetically as per transfer policy clause 5.4 "concession to couples case" working under H.P. Government and Sh. Rakesh Chand is hereby transferred from GHS Mahipur u/c GSSS Bechar Ka Bagh Distt Sirmour to GSSS Charatgarh Distt. Una against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
