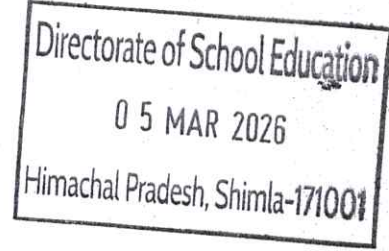

**ORDER**

**Whereas**, Sh. Rajnish Saini, Lecturer (School-New) English who is under orders of transfer from GSSS Soldha, Distt. Kangra to GSSS Makroli, Distt. Kangra has filed CWP No. 1946/2026 before the Hon'ble Court against his transfer orders and prayed that he shall be contented in case, he is permitted to make a representation to the respondents/authorities for the redressal of his grievances in time bound direction.

The case was before the Hon'ble High Court on 19.02.2026 and Hon'ble High Court disposed of the same with the following directions:-

**“Without commenting upon the merits of the case, it is ordered that in case the petitioner makes a representation within two days from today, in that event, the respondents/authorities shall decide the same within a period of two weeks, thereafter, by passing a speaking order and the said order shall be communicated to the petitioner.”**

**“It is made clear that this Court has not expressed anything on the merits of the case and respondents are at liberty to take a decision strictly in accordance with the provisions of law.”**

**And whereas**, as per the direction passed by the Hon'ble High Court, the petitioner was called to appear in person on 28.02.2026. During the course of the hearing, the petitioner pleaded that he is unable to continue at GSSS Makroli (KGR) because this station is approximately 100 kilometers away from his native place, causing extreme hardship. His mother is undergoing regular treatment at Dr. RPMC Tanda, and his father is suffering from paralysis and requires constant physical assistance. Additionally, his two minor children (studying in the 8th and 10th standard) have their board examinations scheduled for March 2026. A transfer at this point would cause irreparable harm to their academic prospects. The petitioner further requested that, considering his family circumstances, he may kindly be posted to one of his preferred stations, namely GSSS Kholi, GSSS Upperli Kothi, or GSSS Gheen in District Kangra.

**And whereas**, upon examining his representation, it was found that he has been posted in District Kangra since 2008, and he has been transferred within Kangra district, which is his home district and a soft area. Hence, it is not also feasible in the interest of students, as currently 36 students are studying at GSSS Makroli (KGR). Furthermore, as per “Comprehensive Guiding Principles-2013” for regulation the transfer of State Government employees it is clearly stated at Rule-12.1 that no government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now **therefore**, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and further directed to join at GSSS Makroli (KGR).

With these observations, representation stands disposed of.


