On the subject cited above I am directed to inform you that in the 8th Apex Level Committee Meeting of NCORD held on 15.05.2025, following issues/concerns were raised by the Union Home Secretary, Govt. of India:



- Most of the States have not created designated Courts to dispose off the cases related to narcotic drug which is resulting in release of the offenders.
- He further raised a concern to strengthen the NCORD mechanism and to speedup the destruction of the seized contrabands under the Narcotic drugs.
