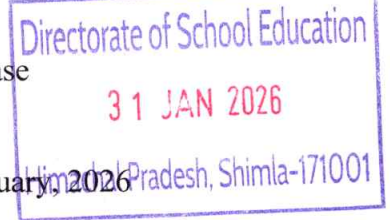

**ORDER**

In the matter of:- CWP No. 50/2026-titled as Rakesh Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 50 of 2026 in the Hon'ble High Court vide which sought his transfer from GSSS Gehra Distt. Chamba HP(sub cadre area) to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 02.01.2026, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 24-01-2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Rakesh Kumar, TGT (Arts), submitted fresh representation and stated that he is working at GSSS Gehra Distt. Chamba i.e. sub cadre area and requested for transfer/adjustment at GMS Hardaspura or GMS Julakhadi Distt. Chamba, on account of completion of normal tenure in sub cadre area and adverse domestic circumstance.

From the perusal of the record, it is found that Sh. Rakesh Kumar, TGT (Arts), has been working at from GSSS Gehra Distt. Chamba since 27.10.2016 and he has completed his normal tenure at present place of posting (i.e sub cadre area of Distt. Chamba) wherein 187 students are enrolled. Further, at present one post of TGT (Arts) is lying vacant at GMS Hardaspura u/c GSSS(G) Chamba Distt. Chamba wherein 54 students are enrolled, which also falls within the choice station of the petitioner.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Sh. Rakesh Kumar, TGT (Arts) posted at GSSS Gehra Distt. Chamba is hereby transferred/adjusted at GMS Hardaspura u/c GSSS(G) Chamba Distt. Chamba without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.

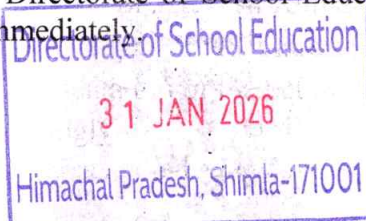
